Public Participation

2. Mr & Mrs Mitchell spoke about their application 18/11291 to provide a car port at 18 Willow Drive and offered members the opportunity of asking them any questions regarding this. No questions were asked at this time.
3. Mrs Sue Goulding spoke about a matter not on the meeting's agenda. She referred to the continuing issue of car exhaust fumes and the emissions generated when cars were stationary with their engines running. She continued by referring to a recent clear air consultation undertaken by Southampton City Council. She was aware that some air quality monitoring equipment was present in Marchwood and asked if this was part of an Air Quality Management Area.

The Parish Council raised no objection to this application.

TPO/18/0936 – Land at Admiralty Way Marchwood SO40 4AG: 10 trees of various species all requiring height and canopy reduction.

The Parish Council raised no objection and supports this application.

TPO/18/0971 – 1 St John's Court Marchwood SO40 4SG: Prune 3 yew Trees

The Parish Council raised no objection and supports this application.

Parish Council priorities for 2018-19

- 9 Bury Road cycle path extension –Cllr Bennison spoke about the proposed extension to the existing cycle path. She explained where it currently terminated in Bury Road and also about where it was planned to terminate.

This would only be achieved if a further parcel of land was received from the Barker-Mill Estate.

Long Lane footpath by Southampton Football Club – an update was provided by both Cllr Bennison and Cllr Hoare. Cllr Hoare has asked for this item to be referred to the Amenities Committee where the proposal requires hedgerow planning to take place.

Cycle / footpath to Hythe – no update

Highway / road access issues such as HGV's using restricted roads – The Clerk spoke about some incidents involving an MOD contracted Haulage Company using unauthorised routes through the village to the Sea Mounting Centre.

Following complaints to the management of the company it transpired that an out-of-date Sat Nav system was misdirecting the Lorries through the village.

The company concerned then readily agreed to provide their drivers with instructions on the approved route into the Village towards the SMC.

Correspondence was received from ABP about their planned improvements to the Eling Wharf.
