The Parish Council takes the view that as many Ash trees as is possible should be protected for as long as possible provided they show no signs of being dead, diseased or dangerous.

This is a splendid local example of a native species and appears to be strong, vibrant and healthy at this time.

We therefore see no justifiable reason for its removal at this time.
